Jund Ansar Allah Threatens "Response" to Hamas Clashes Released on: August 16, 2009

"In the name of Allah the Most Merciful the Most Compassionate."

"May Allah have mercy on our martyrs...By Allah; the Only God, He who raised the folded skies without pillars, we shall avenge your [martyrs] blood [shed] and we will make their women widows as they widowed the women of our mujahideen."

"Those who have invaded the Zionists in their homes and returned back to their families safely and victorious... They have been killed with your hands on Friday night and in these blessed days. All of this took place because of the rumors that Hamas spread about wanting to put the [Ibn Taimiya] Mosque under the control of the Awqaf Ministry [Ministry of Religious Affairs]—and with that decision, repeated the souls of mujahideen and civilians under the pretense that we are deviants and that we are Takfiris. We have always stated and again repeat that we had no connection with any bombing that occurred inside the Gaza Strip. One of the most important sayings of our commander Abu Abdullah [al-Muhajir] (may Allah have mercy on him, we consider him a martyr and we do not exalt anyone over Allah) was when he used to tell younger mujahideen, 'whoever wants to join the group of Jund Ansar Allah and who also seeks to be a Takfiri—you are not ready to work with us.'"

"It should be of some significance for Hamas that Abu Abdullah was one of the most wanted men sought by Israel, and he had assembled a brilliant jihadi and military biography. He was considered a General in military affairs, and specialized in making bullets. He worked with Hamas and provided it with his expertise, most notably speaking in 'SIMlish,' which you have seen the mujahideen of Jund Ansar Allah learning to speak in our publications, and provided them with a training ground. He was also very close to Ezzadeen al-Qassam Brigades commander Mohammed al-Jaabari, Abu al-Shaimaa', and Abu Mu'az... He was very closely related with them. His reward was death when they discovered how much more powerful the Jund Ansar Allah organization would become on the battlefield, and he who wants to truthfully carry out jihad must know. The path of democracy and legislation and elections and the foolishness that occurs between them [Hamas] and Fatah, along with their internal disputes, is not the path of mujahideen—the purpose for which they joined the al-Qassam Brigades."

"Through our website, we officially assure, and repeat again, that we did not intend to bomb any security headquarters or attack any Hamas units like the so-called Fathi Hammad has claimed, and we have no connection whatsoever with any explosion that occurred on the Palestinian battlefield, and we have not called anyone a Kafir, and we are not followers of Al-Qaida, and this was the decision of our commander Abu Abdullah. And now we are awaiting our new commander."

“Allah is sufficient for us, and He is the best of witnesses against this schism that has been ignited by some of the collaborating leaders from Hamas that was heated up by some of the cooperative [traitor] Hamas leaderships—and we wash our hands of responsibility for any events that might take place in the next several days as a result... Await our response.”

“Note: Among other things, the Hamas movement has stolen a total of \$120,000 from the mujahideen of the Jund Ansar Allah organization, along with equipment and weapons. Additionally, there was a piece of land and a house that belonged to the family of Abu Abdullah al-Muhajir which they rented to the Hamas Interior Ministry. Part of the house was destroyed during incidents between Fatah and Hamas, and then the occupation forces bombed it before the most recent battle. The Hamas government of al-Haniya rented the house... and paid no reimbursement for the costs...”
